Interact with rehabilitation team and treatment/service team to provide input on patient progress, needs and overall rehabilitation program. Assist Director of Rehabilitative Services in day to day operation in order to insure program operates on a sound administrative and programmatic basis. Perform other related duties as required.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES: Knowledge of psychiatric rehabilitation principles and techniques. Ability to establish and maintain effective working relationships. Ability to plan, organize and synthesize information for assisting patients in his/her recovery.
