QUALIFICATIONS: Master's degree in Social Work from a college or university approved or accredited by the Council on Social Work Education. Possession of licensure as a graduate social worker as issued by the Alabama Board of Social Work Examiners. Eligibility for and active pursuit of the certified (LCSW) level is preferred.

KIND OF WORK: Provide direct treatment and services as privileged or with supervision for serious and chronically mentally ill adults. Performs psychosocial assessments/social histories for hospitalized seriously and chronically mentally ill adult persons. Performs post-hospitalization planning and implementation for hospitalized seriously and chronically mentally ill adult persons. Performs at least 5 billable hours per week of therapy/casework for hospitalized seriously and chronically mentally ill adult persons. Contributes to the development, revision and monitoring of individualized treatment plans for hospitalized seriously and chronically mentally ill adult person. Provide social work services for hospitalized seriously and chronically mentally ill adult persons and their families. Communicate with CMHC staff, family, significant others in regard to hospitalized seriously and chronically mentally ill adult persons. Communicate with the court system. Demonstrate professional growth and clinical competency by attending/participating in discipline meetings, supervisory/consultations and mandatory in-services programs. Other related functions to include tasks assigned by either the Director of Social Work or Unit Director related to patient treatment. Serve on committees as assigned and participate in providing in-service for Social Work Department.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES: Good supervisory skills and abilities. Knowledge of clinical and crisis interventions. Ability to make clinical assessments. Ability to keep accurate records and write reports. Ability to interact with other professionals in a courteous, professional manner. General knowledge of community resources for the mentally ill. Ability to communicate effectively both orally and in writing.

METHOD OF SELECTION: Applicants will be rated on the basis of an evaluation of their training, experience, and education, and should provide adequate work history identifying experiences related to the duties and minimum qualifications as above mentioned. All relevant information is subject to verification. **Drug test required. Security clearances will be conducted on prospective applicants being given serious consideration for employment and whose job requires direct contact with patients.**
