**QUALIFICATIONS:** Graduation from an accredited school of medicine and successful completion of a residency program in psychiatry as approved by the American Board of Psychiatry and Neurology. Must be board certified in psychiatry by the American Board of Psychiatry and Neurology, and recognized by the AMA or the American Osteopathic Association. Must be board eligible by the American Board of Psychiatry and Board Certified.

**KIND OF WORK:** Responsible for overall clinical responsibility for coordinating patient care. Conducting diagnostic evaluations including mental status examinations and updates, forensic evaluations; prescribing treatment to include medication and other therapeutic measures to control or relieve symptomatic or harmful behavior. Serve on treatment team and be available for consultations daily. Serve on various medical staff committees as assigned. Perform other related duties. On-call rotation.

**REQUIRED KNOWLEDGES, SKILLS AND ABILITIES:** Knowledge of theory, principles, and practice of general and preventive medicine and psychiatry. Knowledge of psychotropic and other medications, symptomatology, treatment and care of the mentally ill. Ability to express ideas clearly and concisely both orally and in writing. Ability to work with forensic patients.

**METHOD OF SELECTION:** Applicants will be rated on the basis of an evaluation of their training, experience and education, and should provide adequate work history identifying experiences related to the duties and minimum qualifications as mentioned above.
